**Currency:** Japanese Yen for both OTG and NFR

**Payment Options:** Credit Card (Visa, MasterCard, JCB)

**OTG Order Limitations:** None

**NFR Order Limitations:** As an NFR Market, there are personal use limitations. Only a two month supply of a given product can be ordered once per month. For example, a person could order 2 Slenderiix/Xceler8, 2 Omega- Q, and 2 Restoriix on one order for the month, but not 3 of each.

**Retail Option for OTG:** Yes

**Retail Option for NFR:** No, Japan currently falls under the NFR (Not For Resale) type. This means that retailing is currently not allowed under these rules.

**Loyalty Program:** Not yet

**Preferred Customer Program:** Yes

**A.S.A.P. Bonus:** Available for Business 500, Elite 1000 and Ultimate 1500 Packs.

**Initial Account Activation Requirement:** 200 points of product sales must be generated in personal orders. This applies for Business, Elite, and Ultimate enrollment packs too.

*\*Activates income position/ eligibility for earning commissions*

**Per Cycle Personal Product Requirement:** 100 points worth of product must be personally generated every 28 days to be eligible for commissions. 200 points of product sales must be generated for multiple income positions.

*\*Or during their qualifying week*

**Commissions:** Direct deposit is available in Japan. Fixed commission rate to be reviewed every few months. 1 USD= 108 JPY

**Marketing Materials:** Under “Library” in XOffice, there are Japanese materials including: Order Forms, 4 Week Calendar, Product Flyers, PR, etc.

**Legal Requirements for Non-Resident/ Citizen:** Specific Working Visa, must be 23 years or older, students are not allowed to participate

**Standard Shipping:**

- OTG: 2 days- 900 JPY fixed rate except Puritii Air Filter – 2100 JPY
- NFR: 5-7 days- actual shipping price
  - Less than 1 pound- 1700 JPY
  - Each additional pound- 200 JPY
- Import duty is also charged for NFR orders (see the price list)

**Enrollment Process:**

Under the Direct Selling Law in Japan, the new enrollee must receive “Gaiyo Shomen” (Company Outline) from the sponsor before signing up and learn about the business and company. Each Gaiyo Shomen has a unique 9 digit serial number which is required to be written on the application form.

All new Representatives must be at least 23 years old and provide the following by fax to the Japan office for the enrollment process:

- a. New Member Application Form
- b. Order Form
- c. Declaration Form (Shinkokusho)
- d. Representatives ages 23–25 must provide copy of their insurance along with proof of the current address
- e. Representatives age 26 and over must provide ID as proof of their age and current address
- f. Foreign Representatives must provide a copy of their Alien Residential Card
